

**GLOCK 35<sup>th</sup> US ANNIVERSARY GRAND PRIZE SWEEPSTAKES  
OFFICIAL RULES**

- 1. NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO PARTICIPATE IN THIS SWEEPSTAKES.**
- 2. VOID IN PUERTO RICO, U.S. VIRGIN ISLANDS, U.S. TERRITORIES AND POSSESSIONS AND WHERE PROHIBITED OR RESTRICTED BY LAW.**

Monthly prize winners will be drawn each month during the current active sweepstakes periods starting January 13, 2021 and running through December 6, 2021. Monthly prizes will consist of GLOCK firearms, GSSF memberships, GLOCK Training Course entries, E-Store vouchers, GLOCK apparel and/or merchandise.

**D. APRIL SWEEPSTAKES PERIOD:** The GLOCK 35<sup>th</sup> Anniversary April Prize (the “Sweepstakes”) begins April 7, 2021 at 2:00 PM (Eastern Daylight Time) and ends May 3, 2021 at 11:59 PM (Eastern Daylight Time) (the “Program Period”).

**E. MAY SWEEPSTAKES PERIOD:** The GLOCK 35<sup>th</sup> Anniversary May Prize (the “Sweepstakes”) begins May 5, 2021 at 2:00 PM (Eastern Daylight Time) and ends June 6, 2021 at 11:59 PM (Eastern Daylight Time) (the “Program Period”).

**F. JUNE SWEEPSTAKES PERIOD:** The GLOCK 35<sup>th</sup> Anniversary June Prize (the “Sweepstakes”) begins June 8, 2021 at 2:00 PM (Eastern Daylight Time) and ends July 5, 2021 at 11:59 PM (Eastern Daylight Time) (the “Program Period”).

**G. JULY SWEEPSTAKES PERIOD:** The GLOCK 35<sup>th</sup> Anniversary July Prize (the “Sweepstakes”) begins July 7, 2021 at 2:00 PM (Eastern Daylight Time) and ends August 2, 2021 at 11:59 PM (Eastern Daylight Time) (the “Program Period”).

**H. AUGUST SWEEPSTAKES PERIOD:** The GLOCK 35<sup>th</sup> Anniversary August Prize (the “Sweepstakes”) begins August 4, 2021 at 2:00 PM (Eastern Daylight Time) and ends September 6, 2021 at 11:59 PM (Eastern Daylight Time) (the “Program Period”).

**I. SEPTEMBER SWEEPSTAKES PERIOD:** The GLOCK 35<sup>th</sup> Anniversary September Prize (the “Sweepstakes”) begins September 8, 2021 at 2:00 PM (Eastern Daylight Time) and ends October 4, 2021 at 11:59 PM (Eastern Daylight Time) (the “Program Period”).

**J. OCTOBER SWEEPSTAKES PERIOD:** The GLOCK 35<sup>th</sup> Anniversary October Prize (the “Sweepstakes”) begins October 6, 2021 at 2:00 PM (Eastern Daylight Time) and ends November 8, 2021 at 11:59 PM (Eastern Daylight Time) (the “Program Period”).

**K. NOVEMBER SWEEPSTAKES PERIOD:** The GLOCK 35<sup>th</sup> Anniversary November Prize (the “Sweepstakes”) begins November 10, 2021 at 2:00 PM (Eastern Daylight Time) and ends December 6, 2021 at 11:59 PM (Eastern Daylight Time) (the “Program Period”).

**9. ELIGIBILITY:** The Program is open only to individuals who are legal residents of the 50 United States and the District of Columbia, who at time of participation are 21 years of age or older and are not prohibited by law from possessing or operating a firearm. Employees of Sponsor and its parents, subsidiaries, and other affiliated companies, agents, and advertising and promotional agencies, and their immediate family members (defined as parents, spouse, children, siblings, grandparents) and those with whom they are domiciled, are NOT eligible to participate in the Sweepstakes and are NOT eligible to win the Sweepstakes prize.

**10. GENERAL CONDITIONS:** This Program is subject to all federal, state and local laws and regulations.
